



By-law # 2002-02
Tax Exemption By-law and Schedule A

BE IT RESOLVED that the following be adopted and enacted as a bylaw of the Municipality of the District of Digby under the authority of the *Municipal Government Act*, S.N.S. 1998, Chapter 18.

1. The property taxes due as regards certain taxable property or properties of certain organizations are hereby reduced to the extent indicated in Schedule "A" attached.
2. The percentage exemption granted to a particular property as indicated in Schedule "A" applies to any applicable Area Rates as well.
3. To be eligible to be placed on Schedule "A" the owner of the property must meet the requirements of Sec. 71 (1) of the *Municipal Government Act* and Council must pass a motion authorizing the addition of that property, by amendment to this bylaw.
4. When a property listed in Schedule "A" attached ceases to be owned by the organization named then the exemption shall cease and the new owner shall immediately be liable for the full property tax on the entire property for the remainder of the taxation year.
5. This bylaw shall be effective for the 1999-2000 taxation year and each year thereafter.
6. The Bylaw Respecting Tax Exemptions for Fire Companies and Nonprofit Organizations currently in force in the Municipality of the District of Digby, is hereby repealed.
